

敬啟者：

香港政府為減輕家長在教育支出方面的財政負擔，由今學年起將「學生津貼」恆常化，現正接受申請。「學生津貼」不設資產審查，所有在申請日在香港就讀於提供本地或非本地課程的中學日校、小學和特殊學校(包括公營學校、直資學校、英基學校及私立學校)及幼稚園的學生皆可獲得有關津貼，但夜校學生、自修生、持學生簽證來港就學及持有入境事務處發出擔保書的學生不符合資格。

現隨通告附上每位學生的「學生津貼」申請表，家長請先細閱表格內的「須知事項」以及「聲明」。成功批核的津貼將直接由銀行戶口發放，敬請家長在填寫申請表時，務必小心填寫銀行資料並進行核對，以免影響津貼的發放。

現階段，申請人無須提交其他文件，香港政府會儘量善用現有學校及學生資料進行核實工作，有需要時才要求申請人提交其他文件。教育局會適時透過短訊和電郵，讓家長知悉申請進度，請家長耐心等待。

敬請家長填妥回條，並於 10 月 29 日(星期五)或之前交回已填妥的申請表連同回條到學校，以便跟進。

Dear Parents/Guardians,

One-off Student Grant 2021/22

To alleviate parents' financial burden in defraying education expenses, a one-off student grant will be provided by the government in the 2021/22 school year. The student grant will be non-means-tested. All students, as at the date of application, studying in secondary day-schools, primary schools and special schools (including public sector schools, Direct Subsidy Scheme schools, English Schools Foundation schools, private schools) as well as kindergartens, are eligible for the grant. Students of evening schools, students of private studies, holders of student visa for entry into Hong Kong for studies and holders of Form of Recognizance issued by the Immigration Department are ineligible.

Please check the enclosed application form for student grant, please clearly read the notes as well as the declaration. **The subsidy will be reimbursed to parents via bank transfer. Please make sure the bank details are clearly and correctly marked, double confirm to ensure the smooth of grant reimbursement.**

Applicants are not required to provide other documents at this stage. The government will make use of existing school and student information to carry out verification. Applicants will only be required to provide documents when necessary. The Education Bureau will keep parents notice about the processing status via message and email.


Note 1: If the applicants submit their application forms within September 28 and October 8, our school will submit this batch of application forms early to the Education Bureau.
